SECTION 7. HANDLING AND STORAGE

Handling

If this product is stored or applied in high-pressure systems such as grease guns or hydraulic lines, there is the potential for accidental injection into the skin and underlying tissues. Hydrocarbons injected into skin or underlying tissues are not readily removed by body fluids and can cause pain, swelling, chemical irritation, infection and tissue destruction. Early symptoms may be minimal. Workers must be aware of the significant hazards associated with a hydrocarbon injection injury.
